Delinquent Payments

As resolved in a meeting of the general membership of the club 2 November 2013 the rules and regulations of the club are amended as follows:

5. A member who has not paid fees owing in full by May 31 (as outlined in the Rules and Regulations) will lose the berthing assignment which he/she has been given and will drop to the bottom of the seniority list. This reduction in seniority will take place only after a member of the club Executive has spoken to the delinquent member to resolve the issue, and in any case, no earlier than June 30.
